ORDER

Whereas vide Show Cause Notice dated 19.05.2013, on the basis of report from South Delhi Municipal Corporation that the Unauthorized colony is commercial, the President of the Society of Indra Park, Indra Market was called upon to show cause to why the society's application dated 30.01.2008 for regularization and provisional regularization certificate dated 17.09.2008 issued by the Urban development Department to the society should not cancelled and action taken in accordance with the law.

And whereas the reply of Show Cause Notice submitted by the President of RWA on 01.04.2013 and request to hear in person before taking coercive and perceive decision in the case. The request was accepted and RWA was given personal hearing on 22.05.2013 at 3.00 pm and in the interest of justice RWA was given time to file the reply, if any, by 29.05.2013.

And whereas in response to the Show Cause Notice the RWA filed a reply on 29.05.2013 was examined and it was found that no document proving the residential nature of the colony is submitted by the RWA.

And whereas RWA President in his reply of Show Cause Notice is accepted that commercial activity are being carried out in this unauthorized colonies in order to earn their livelihood.

And whereas as per the inspection conducted by the Urban Development Department it has been found that the entire area is fully commercial and no sign of residential activity was found at the site and hence the application dated 30.01.2008 submitted by the Society is not eligible for regularization as per the Revised Guidelines 2007 for Regularization of Unauthorized Colonies in Delhi and regulations for regularization of unauthorized colonies dated 24.03.2008.

Now therefore, in view of the above the Provisional Certificate of regulation no. F.1-33/UC/UD/2004/Part-III dated 17.09.2008 issued to Indra Park, Indra Market, village Munirka (UD registration no. 1610) is hereby cancelled. The application dated 30.01.2008 submitted by the said RWA for regularization of Indra Park, Indira Market, Village Munirka, New Delhi is also hereby cancelled.
