The Board shall advise the government on issues connected with the infrastructural development of, and for securing the planned growth of the Trans Yamuna Area , so as to reduce the disparity in development between Trans Yamuna Area and other areas of Delhi.



The functions of the Board shall be as under :-

- i) to study the drawbacks in the existing infrastructure and to formulate a unified and coordinated Area Plan keeping in mind specifically the functioning of the Municipal Corporation of Delhi, Delhi Development Authority, Delhi Vidyut Board, Delhi Jal Board, Public Works Deptt., Irrigation & Flood Control and the Slum Wing of the MCD in this area.
- ii) to recommend the priorities of the projects and schemes included in the Area Plan and the stages in which the Area Plan may be implemented.
- iii) to examine the nature and the extent of over-lapping functions, if any, so as to secure an improvement in the provision of services and for quicker redressal of public grievances.
- iv) to review, from time to time, the implementation of the projects and the schemes included in the Area Plan and recommend measures for effecting coordination amongst the organisations and Departments of the Government in the matter of implementation of such projects and schemes.
- v) to review the progress of the implementation of the schemes and to recommend to the Government of Delhi the quantum of financial assistance required for the execution or implementation of any project or scheme in the Area Plan, or to be included for the subsequent financial year.
- vi) The Board shall have a Secretarial staff consisting of a Secretary and such other officers and employees as the Government of NCT of Delhi may by order determine.

Funds will be placed at the disposal of the Board for the discharge of the above mentioned functions. The Board, on examining the detailed existing plans for the area, will allocate these funds to the Department/Organisations concerned for executing specific schemes.

The Board may as and when considered necessary, co-opt any other person as special invitee.


