Sub: Minutes of the 58th meeting of Trans Yamuna Area Development Board (TYADB) held on 04.09.2018 at 03.00 P.M in Conference Room No. 3, C Wing 2nd Level Delhi Secretariat, New Delhi

List of participants who attended the meeting is at **Annexure 'A'**

At the outset, the Chairman (TYADB) welcomed all the members of Trans Yamuna Area Development Board (TYADB). The Action Taken Report/Minutes of the 57th meeting of the TYADB held on 13.03.2018 were detailed and approved unanimously. Thereafter, the agenda of the meeting was taken up.

The following were discussed and decided in the meeting:

1. The Chairman, TYADB informed the members of the Board that budgetary allocation of fund under the Trans Yamuna Area Development Board has been kept at Rs. 48.00 Crore in the Budget Estimates -2018-19. Out of which, approx. Rs. 28.00 Crore would be required to meet out the committed liability of works recommended/sanctioned during previous year i.e. 2017-18. Thus, an amount of Rs. 20.00 Crore is available for recommendation of more proposals during the current financial year 2018-19.
2. The Spl. Secretary (UD) informed that work proposals of estimated cost of Rs 112.47 Crore have been received from the members of the TYADB. Thereafter, the Chairman decided that funds up to Rs 1.50 Crore would be allocated for each members of the Board for development works as per availability of funds.
3. It was also decided that the additional funds would be demanded under TYADB Scheme from the Finance Department, GNCTD at the time of Revised Estimates.

(Action –UD Department/Finance Department)

4. Due to fund constraint, the Chairman advised the Hon'ble Members of AC No. 55, 57, 63, 69 and 70 to submit work estimates up to Rs. 1.50 Crore per AC within week. It was decided that the works would be approved by the Chairman after proper scrutiny in the UD Department.

(Action- Hon'ble Members of AC No. 55, 57, 63, 69 and 70/ UD Department)

5. (i) The Chairman has also directed that meetings of the TYADB should be convened after every two months for review of progress of the works/projects recommended/sanctioned under TYADB Scheme with the executive agencies. Since, the major portion of developmental work under TYADB is being carried out by the East DMC, hence the Commissioner (EDMC), Addl. Commissioner



(EDMC) and Chief Engineer (EDMC) should be present to submit consolidated progress report instead in piece meal. The Board showed their annoyance about slow progress in execution of works by EDMC which ultimately effecting entire process of scheme resulting delay in completion of work on time, non-utilization/laps of funds. Hence, it has been directed by the Board that EDMC should streamline process of sanction/tender and execution of work for timely completion of TYADB works.

(Action- UD Department/EDMC)

(ii) The Chairman expressed concern on the fact that East DMC, DUSIB and I&FC Department, GNCTD has not submitted that work-wise progress report in respect of already sanctioned works. The officers of the concerned executive agencies were directed to submit Monthly Progress Report to UD Department on regular basis. Each executive agency should also designate one Nodal Officer for coordinating the works of the TYADB.

(Action- Executive Agencies viz. East DMC, DUSIB, I&FC, DSIIDC)

6. The Chairman intimated that one of the reasons for delay in completion of works was that funds were released in three installments i.e. 50% at the time of sanction of the work, 25% amount after the completion of 75% of the work and final payment after completion of the whole work as per the minutes of the 56th meeting of the TYADB. Now, it has been decided that funds under the scheme would be released in two installments i.e. 50 % of the estimated cost at the time of sanction of the work and remaining balance amount after 75% completion of work on the basis of the contractual cost subject to furnishing of certificate by Member/Executing Agency.
