ORDER

It has been brought to notice that it is unclear as to whether work related to shifting of HT/LT line can be carried out in other than 895 unauthorised colonies as the UD Department Memorandum NO 18(385)/A/UD/Plg./2013/8213 dated 23/9/2013 provides that projects of shifting of HT/LT lines will be considered initially in 895 unauthorised colonies covered under this department's order dated 04/09/2012 and also in unauthorised colonies in respect of which orders will also be issued in due course of time as per Regulation for regularisation of Unauthorised Colonies dated 24/03/2008.

In this connection attention is drawn towards order dated 29/12/2015 of Urban Development Department wherein it was ordered that "for the purpose of carrying out development works no distinction should be made between the colonies eligible for regularisation under the Regulation for Regularization of Unauthorised Colonies and other colonies. Development work should be undertaken in all the unauthorised colonies. The only exception to this rule will be in respect colonies falling inside forests area and colonies coming in the area under ASI Regulation."

It has now been decided that shifting of HT/LT line can be construed as development works activity and includes in the scope of work under The Plan Scheme "Provision of Essential Services in Unauthorised colonies." The conjoin reading of order dated 23/09/2013 and order dated 29/12/2015 makes it explicitly clear that development works related to HT/LT lines can be carried out in all 1639(1797 with parts) unauthorised colonies which are under examination for regularisation and are otherwise eligible for development works in terms of instructions of Urban Development Department, without any discrimination.

This issues with prior approval of Hon'ble Dy. Chief Minister/M/UD Govt of NCTD.
