ORDER

Whereas in pursuance to the public notice/Advertisement in 2007-08 issued by this Department, for regularization of unauthorized colonies, the RWA, Jan Chetna Sangam (Regd.) Mandawali Uncheper, Delhi-92 with Registration No. S/16491 of 1986 submitted an application for regularization of unauthorized colony Jan Chetna Sangam (Regd.) Mandawali Uncheper, Delhi-92 through Shri Ashok Kumar Sain, President Jan Chetna Sangam (Regd.) and the said application was issued Regn. No. 53-LOP.


And whereas an order No 1-33/UC/UD/policy/2012/549-553 dated 04.9.2012 has been issued in respect of 895 colonies including the above said colony at S.No.79 of list-Annexure-II.

Whereas it has been brought to the notice of UD Deptt. by the RWA itself that their colony was approved by DDA vide Resolution No. 125 dated 30.07.1983 under unauthorized regularized colonies of village Mandawali Extn. and is given as S.No. 483 of the Delhi Municipal Corporation Act 1957 under the U.R. Colony. Hence, approving/regularizing it again could be wrong and requested to cancel the new approval given recently to their colony.

Therefore, in view of above facts, the application of RWA for regularization filed vide 53-LOP (PRC not issued) is hereby cancelled and name of UC Jan Chetna Sangam (Regd.) Mandawali Uncheper, Delhi-110092 (S.No. 79- Annexure-II) having Regn. No. 53-LOP is hereby deleted from office order No. 549-553 dated 04.9.2012 with retrospective effect.

This is without prejudice to other action that may be taken as per law.
